Transcript - Minutes – 8th Annual General Meeting 2020 – Rainbow Cities Network

November 5th 2021

Juliane Steeger: Yes. Welcome everybody to the 8th annual meeting of the Rainbow Cities Network. A very warm welcome on behalf of the board. I'm Juliane Steger. I'm the chair of the board. I'm working as a representative for us for Gender and Sexual Equality at the city of Hanover in Germany. And as I said, I'm also the chair of the board for two years and appeared is running to an end today. My board colleagues, I want to introduce are Anouk Erkelens from Rotterdam and also Marije Pluym. I hope I say it right, from Amsterdam took over the last week. Then we have also the Guillaume Mandicourt from Geneva, from Switzerland. Danny Jacqmot from the capital region of Brussels. And our secretary is Sören Landmann from Mannheim, not part of the board, but also important is Manuel Rosas Vázquez, our coordinator, you who he is.

Yes, today we come together from not only from different parts of the world, but also from different time zones. So, it's a 3:00 PM coffee time in central Europe. And I would like to work on the colleague from Taiwan where it's 8:00 PM right now, in Iceland, it's 2:00 PM. The member city Sao Paolo, it's lunchtime 12 and in Mexico City, it's 9:00, it's time for breakfast. So, it's a bit funny that which times zones, sadly, this year we can, we cannot meet in person meet in person because of the worldwide pandemic of COVID-19. So, we decided to do a light online conference. Light because after all these months, most of us working at home and in online conferences, we know all how exhausting it is to sit in front of a computer and talk to the computer. We hope that we can meet in person next year.

So, we decided to do the minimum requirements for our online conference this year why at that medium after the two-year period for the board is over, we need to do new elections and we also want to present to you what happened in the previous years. And then we also have some new cities who joined in 2020, and also, we don't know Reykjavik who also joined last year, but couldn't make it to the annual conference in Luxembourg last year. As you all know, the rainbow cities networks consist of exchanging experiences and staying in touch. So, we all want you to meet each other, at least online before we hopefully can meet again. We decided against any inputs on special topics, because we know how hard it is to follow online. For more than two hours, we made

our annual board conference online this year in June, after we try to meet in person Rotterdam, but as you know, it wasn't possible.

And we met about three days, four hours a day, and it was really exhausting for all of us. So, we hope next year we can have any scientific input and yes, that's it for the day. We also want to be able to discuss all the topics you might want to talk about, but that's a bit difficult too. So, we hope that you can spare them for next year's conference so we can organize the things and topics much better than here. As you may all saw, the conference is recorded. You have all these little red buttons in the corner of off your desktop that's because Sören is doing the minutes for the meeting there. We only use it for doing the minutes after everything's completed, we will delete it. And I hope it's okay for you. So, that's it for right now. We want to do a roll call. Juliane Steeger: So, I'm very impressed that there are only two cities missing, so that's pretty great. It's only Oslo and Linz if I'm right. So, and that it works like that. Yes, I'm really impressed. So, 31 cities are there and now I'm taking over to my wonderful colleague and our coordinator Manuel. #00:30:12#

Manuel Rosas Vázquez: Thank you. It's really great to see you all at least on the screen today. So, as you can see, I hope you were able to review the agenda and also there was a procedure and of course the report. So, thank you all for being here. And if you allow me after the roll call, I will read the agenda and then I will proceed to show you a poll. What everyone, well, not everyone, only this, your representatives can vote. So, this is going to be, let's say our exercise to see how it works. So, I really urge you for those who have two let's say delegates from the same city, only the representative that is the member of the network can vote. That means if I'm not mistaken, we have 31 cities present. That means that when I release the poll you will have three minutes to vote or when I received 31 votes, I will close the poll.

And that will mean, yes, no or the abstentions, according to what you express, but please. So, once again, especially for those who have two persons in one delegation, only one person can vote and please always the same person. And at the end of the meeting, I will be able to create the report. So, I will see who vote. So, of course I hope that the instruction is clear and that will not affect the results of the polls. Is that clear? I hope so. Okay. So, if you allow me the meeting or the agenda is as follows. So, from 3:00 to 3:45, we have the official welcome. And the agenda for the meeting, then we have the official welcome that already happened with Juliane. We had in 0.1, 0.2, the roll call that already happened.

Now, we did it 1.3, which is the adoption of the agenda. 1.4 is the rules of procedure from 3:45 to 4:00. There will be a show welcome to the new member cities from 4:00 to 4:45, there will be the presentation of the annual report which will be conducted by Juliane, the chair of the board. And also, from Anouk, which is the board member in charge of finances. Then we'll have a short break of 15 minutes, so you can go for a coffee or make a technical stuff somewhere. So, and then from 5 to 5:15, that will be the election of the new board, 2020 to 2022. Then from 5:15 to 5:45 we'll reached 0.5, which is common projects and conclusions. And then there, they would have the Rainbow Citizen Network for the exhibition. There, my colleague Wolfgang will take the floor for five minutes to tell you about the exposition.

Then we will proceed with the voting. Then in .5.2 our dear colleague ??? from Bergen will take the floor for three minutes and tell you what is expected to happen next year. And then .5.3, it will be miscellaneous. And in .5.4, there will be close and remarks also may by Juliane. Day two, which is tomorrow from three to six, we'll have our first session knowing the new members cities. So, I invite you all those who having confirmed their participation to confirm. So, you will be able to see what our new member cities are doing on the LGBTI agendas. And then the first one will be Kotor. Then 1.2 will be Cork, 1.3, that will be Frankfurt am Main. Then from 4 to 4:15, there will be a break. And then finally from 4:15 to 5 we will start with Heidelberg presentation then Linz, unfortunately, won't be able to attend not today nor tomorrow. So, there's going to be this change. Linz is going to be cross out and then Taipei, it's going to be our next I mean tomorrow the second presentation, and then that will be the end of the day. So, I hope it's clear for everyone. So, now we're going to proceed with the first poll, and I will ask you again to only those who are representing the representatives as his vote with the agenda. Is everybody seeing the voting option because I have received only 26 votes so far.

Sören Landmann: Manuel are you able to see that Sanne, wrote in the chat that she can't use it? Do you have another solution for that minute?

Manuel Rosas Vázquez: No, I don't, but I mean, usually it shouldn't be a problem because everybody's joining from the browser, isn't it? #00:38:57#

Sören Landmann: That's the short idea. It's a pop-up window. So, if you maybe have blocked pop-up windows, this could also be an issue.

Adriana Aguilera: Probably Mexico city has already voted. Can you see our vote? Just make sure. #00:39:40#

Manuel Rosas Vázquez: We will see only that at the end of the meeting, when the report is created. Oh, okay. But I mean, we have received 28 votes, so I will meet missing three votes basically, which it makes sense that Brazil is not voting. I think Bergen is also not able to vote and who else is missing and Reykjavik cannot vote. Right. Is that correct? #00:40:15#

Sören Landmann: So, what we can do is maybe that they write you a personal message with how they want to vote? #00:40:22#

Manuel Rosas Vázquez: Yes. I will ask the three three cities in the chat. So, it's recorded somewhere. Could you please vote a yes or no, or an abstention in this first question, please? Okay. Brazil voted yes. So, I'm going to close the first poll, so you will be able to see the results. Okay. So, as you can see, 28 votes in favor, plus Brazil on the chat Reykjavik and Bergen, can you please write it? What is your vote on the chat so we can count please? Okay. Reykjavik. Okay, now you got it. Okay. Thank you. So, we have 31 votes in favor. So, I will continue with the program. Oops, sorry. Okay.

So, the agenda it's been approved. So, now we're going to pass 1.4, which is the rules of procedure. I hope that everybody read the rules of procedure for this meeting. So, since we don't have so much time, I will not stop in every point of the rules of procedure. I would just like to ask you if any of you have some questions on the rules of procedure? No one? Great. So, if there is no rules of procedure not many questions and the rules of procedure, we are good on the time. So, I think we can start with point number two, which is the welcome of the new member cities which I have the honor to welcome today. Six more new cities that despite the COVID-19 pandemic, we were still able to contact these cities. And also, they were also interested in joining us. So, unfortunately, we cannot clap them because of the sound, but I will like to warmly welcome the city of Kotor, the City of Cork, the city of Frankfurt at Main, the City of Heidelberg, the City of

Linz and the City of Taipei. So, welcome warmly on behalf of the rainbow cities and also from the board. And I invite everyone that tomorrow we'll have a whole session dedicated to them.

So, they, you guys can meet them. And also, they can share with us while the great work that they're doing in their respective cities. So, once again, to these six new cities welcome. And we will have time tomorrow to talk more directly with you. So, if you agree, we can proceed with the annual report. And then I will get back to the chair of the board, which is Juliane. And I will ask her to start the presentation before I start. Sorry. Can everyone see my screen? Because I will be, I mean, then you will be able to see the presentation. Yes. Okay, great. So, once again, I go back to Juliane. #00:45:06#

Juliane Steeger: I am press that we are, that we are right in the schedule that everything is fine with the time. So, I'm bet, I can't write any messages on this program, but I'm sure I will sort out how it works. So, later on yes you may have all read the annual report from the board about the last two years. So, I want to reread that again or tell you what has happened within the last two years on behalf of this report you all received. I choose to tell you a bit about the history, what happened within the last two years from our perspective of you. What will go on. What happened and, in the end, feel free to ask any questions that might bother you, that you want to know.

We hope we can answer everything. So, I will start and later in the annual report new step in for the finances, and we'll have a few minutes to tell you everything about the financial stuff. So, you know what had happened with your member fees. So, as you may know we've elected this board two years ago at our annual meeting in Barcelona and we are the association deed says that we have to be five board members, at least three, but we have to be five. So, we were the City of Hanover, Rotterdam, Brussels, Heidelberg, and this year Paris was elected and we had our first meeting on the next morning and a lovely coffee shop in Barcelona across the town hall. And it was a constitutional first meeting where we decided that I will be the chair, Anouk stepping in from Rotterdam for the finances and Sören will be the secretary.

Then we had a few things. We I said, Heidelberg, Oh, dear Mannheim. I'm so sorry. That's the biggest mistake of today. So, then we had well, Heidelberg and Mannheim is very close to each other, at least one region. So, then we decided what will be the next steps. So, it's really important to create an association and legal one that happened within the next summer to countless support from annual funding from the City of Amsterdam and the City of Rotterdam created the association. Then we tried to get a bank account that was much more harder than we thought it would be. So, we discussed several bank institutions and how it will work. And in the end, I traveled

to Rotterdam and Anouk and I had an appointment and opened a bank account at the ING. And then what we didn't know was that it took months to make a background check about our board members.

We were, we needed to be checked. So, finally, I think in October or November, we got a bank account and then we collected fees soon afterwards. Also, with creating the association we connected all the cities who wanted to be a part of the rainbow cities network but stayed in line because we weren't that far without being an association. So, in June of 2019, I wrote a long email to all the cities who wanted to be a part. And soon after that Arhus, Bern and the City of Reykjavik joined the network because we were ready to take new participants. So, then we had also the annual conference and Esch to organize last year which was really nice. Thank you, Dominique again. And there was the problem of getting a coordinator.

We made a job application and things like that. It was quite a problem to find a collaboration partner. As you may remember, there was a German association from Hanover who applied for being a partner and being in being the official boss of the coordinator, because we aren't able to be to pay all the taxes and all the things that's really a lot of afford. No one in the board can do. So, we were searching for a partner and we had one and they stepped back because of tax reasons that was big discussions and laws and things like that. So, we looked for another one.

And found another one here in Hanover. It's the QNN Lower Saxony. So, we are working together with them. They are hosting Manuel's job and we pay everything. And but that will, you will see within the finances, how is that working. Yes, that's we also had the problem, not the problem, but it was a huge afford to found ourselves within the board to be a team. We all put a lot of afford and work on it. And a lot of passion. And on this point, I really want, I want to say a thank you to the board to my colleagues, to Danny, Sören and Marije and Guillaume. It was really nice to have you. And I saw Olso was there is that right? No, that's good. That's only one city missing then. And so, what come Oslo. Yes, it was really good to work with you, but it was also hard in the beginning we were much more into founding the network and searching everything else out. And now we are more into planning for the future and thinking about structure or things and things like that. So, it really changed the work within the board. So, but after the agreement with QNN Lower Saxony, we found a coordinator, Manuel, who the most of you met last year in Esch. And he started in January this year. And after that he reached out to two other networks. We were evaluating the things, how it's within the network, what's existing stuff. We've talked about the website about one page is things we might need, yes. To change or to work on those. So, that

you have an overview about the collaboration partners and how much of you participated on the exhibition, on the photo exhibition and things like that.

If you have question to that Manuel can much better talk about that because as you all know I was pregnant and I really very much stuff to do that summer. So, Manuel really has done that pretty well. So, I think that's it. So, then Manuel reached out to new members, I think we've said it 10 times before. So, we have six new cities in 2020 right now within the network. That was, and he, as also said, he reached out to other networks. Also, the social media channels began to start. So, we didn't have Facebook, Twitter, Instagram before, but now we have, and I'm really proud of, because now I can share everything and use the hashtag Rainbow Cities Network. That's also new things he started. So, I think that's the most of the things I've talked about the last two years. Do we want to go on with the finances or what do we want to do?

Manuel Rosas Vázquez: So, we've done with this far, so we're going to go through the finances next with Anouk. And then after Anouk is done, we going to open the floor for questions or comments, and then the cities can make their questions. So, please send your questions. Just on the chat, not as a direct message, so everyone can see just in the general chat. Right. I don't know. Mannheim and then I will see that Mannheim wants to make a question. And then the order that we will follow is first come first serve. So, that person who writes first after, just after we opened the floor, in that order, in that same order, we're going to start giving you the floor. I want to remind you that you will have three minutes to make your questions or comments.

If you exceed those three minutes, I will have to mute you, not in a bad sense. It's just that we will like to give the word to as many members as possible. So, I hope that is clear. So, once again, once we opened the floor, you just have to write in the chat, not direct message to me, just in the chat, so everyone can see that you want to make a question or come in, and then in that same order, I will give you the floor. All right. So, I think it's Anouks time. #00:54:56#

Anouk Erkelens: Yes. Thank you, Manuel. Also, the next slide from the finances, please. Yes. Thank you. So, on the 1st of July, 2019, our network at 27 members and I will tell you a bit more about how we collected the income. So, for 2019, unfortunately three cities didn't pay their fees, which were Mexico City, Sao Paolo, and Barcelona. This means that in total, we received 48,600 instead of the expected 58,200 euros. But also, in the more positive note, two cities we're able to give a solidarity contribution on top of their regular fee, which were Esch who payed 2000 Euros more and Hamburg who paid 1800 Euros more. So, in total, we received 3,800 Euros extra. And

we would like to thank the, these two members for their commitment and solidarity to the network. So, then we go onto the income for 2020. So, that is the one on the right.

And on the 1st of July, 2020, the network had 30 members. For 2020 Mexico City applied for solidarity reduction. And the board also agreed for, to give this reduction fee to Mexico City. Sao Polo also asked for the solidarity reduction, but we didn't receive a formal request yet, but we are in contact with them about this. So, for 2020 Mexico City paid the fee of 500 euros as stated by the bylaw, which is the minimum fee at the close of the first fiscal year, which is on June 30, 2020, because our fiscal years from June until June there were a few cities who didn't pay the fees yet, but the year was of course not over. So, we already now, because we're in our, now in November, we received some extra money, but this report is until the 3rd of June. So, we didn't receive that money yet. So, that gives us a total of 43,085 the 13th of June 2020. So, that's it for the income. Then we can go on to the expenses.

Thank you. So, I will walk you through the table of the expenses very shortly, because you of course, could read everything in the reports, which we have sent you two weeks before this meeting. So, the biggest part of the expenses is the QNN arrangement, which is the contract we have for our coordinator. Starting on the 1st of January 2020 rainbow city's networks, hire the coordinator who was employed by the QNN, like Juliane told you before, therefore the network signed the contract with the QN N to organize the employment of the coordinator. The costs are 55,500 I am not so good with numbers, although I'm the treasurer, sorry for that. The costs are divided in travel cost, personal cost, and also overhead. And we decided for the second half of 2020 to also expand the hours of Manuel and therefore paid an extra 7,000 Euros. The online tools, which are 9% are the new website, which we launched last week.

And we also sent it to you. So, I think you have seen it already. I personally like it very much. And also, we have a mailing list where you get your emails from, and we have to pay for that mailing list. So, that is also a cost, which we have. For the working infrastructure, which is 8% as you can see, that is the 5,000 Euros for the corporation and the working infrastructure for our coordinator. And the smallest part is the board expenses. We have made some costs for traveling because like Juliane said, she came to Rotterdam to open the bank account. And also, another board member had to travel to Hanover for the interview of the coordinator. These costs are of course, very low. It would, would have been higher if our board meeting in Rotterdam would have happened in April this year, but of course, due to COVID, it didn't happen. For the balance, which is the next sheet. Is this a very simple thing. The Balance shows the total income for the financial

year of 2019, 2020 on the left, and then on the right, the reserves in gray, which are the expenses, and then also the general reserves, which are in pink. That's it. Thank you. #01:00:03#

You all members, you have all the detailed information in the report, so I hope you were able to read it. Could you please give some information, for example, is it possible to participate for local youth organizations? And the second one is the concerning the EU project. I would be interested to get some information's. I really find it wonderful to read how many things have been done. And I thank you very much for that. #01:03:46#

Manuel Rosas Vázquez: Thank you very much. So, next I will answer your question. So, just before I answered the question. I will have Mexico City after I finish. And then again, all those who wants to make comments or questions, just write your name on the chat. So, the first question the MAC event. So, before all the events and all the actions that I been undertaking on behalf of the Rainbow Cities Network, I discuss everything with the board. So, let's say that they kind of give the green light before I do it. So, MAC it's an organization in Paris a youth organization, and basically, they contacted us to help them and also. So, they are basically running a global conference next year. It was supposed to happen this year, but of course, because of COVID, it was postponed and it's happening next year in Paris.

Of course, the focus is are they focusing on youth organization. So, they want to make the global youth network, that's the outcome of the organization and where are we going to do our network is the last day. So, the organization or this event it's, he's going to be a sponsor with or a nonactive participation from the can Canadian government at UNESCO. Also, I think he, I mean, he is the director Omar is the name is the director of this organization. And he used to be in contact with the with Wolfgang, I think also from different cities and also the ambassadors from those countries like Austria within UNESCO, they are supporting the event. That was information that I have. So, what are we going to do? Is that the last day there's going to be a side event that it's going to be, let's say we as network, once everything is let's say the money it's guaranteed, they are doing that. So, we're just basically, we're going to bring the cities or invite you guys who wants to come to the event to present what they're doing, where you, I mean, your best practices to all other city networks that are host within the UNESCO, right? So, and within that also we, then with the money we're going to bring yes, youth organizations. So, right now we have all their particular interests of this MAC is to have organizations from the global South. So, of course we are. I mean, not only that's important, not only, but for instance once they get the money, we going to be in contact with Sao Paolo with Taipei and Ljubljana, particularly to bring their youth because of course this organization is looking to pay for the cost of those participants, which I mean, traveling from Munich to Paris is not as costly as traveling from Sao Paolo or Taipei to Paris because of course the plane is more expensive.

So, yes, just to answer your question, yes, your organizations can participate and of course, we're going to bring not only you guys as the cities, but also if you said like we would like to bring, I don't know, one to three participants from the organization. Yes. Again, those details will be cleared out once they have their whole budget, that they have plan approved. That's why we haven't get back to you with all the details. That's the only reason, but that's what is going to happen. So, we are

going to participate and the site event the last day of the conference with the panel, basically having five, six cities as everything I'm going to send the invitation open to everyone. And the first sakes who reply will be the first who will participate. Of course. Now it's taken the chance will be really interesting to have Sao Paolo and Taipei, because of course they are looking to expand or to have a broad end spectrum in the global South.

And, and yes. So, that's for the first question, the second question, when it comes to the European Union project. So, as I told you on my email, I know the rainbow cities network applied for resources two years ago, I think and this year we also applied for the same program. And as I explained in my email the aim of this project is to create the first LGBTI policy guidelines for cities, because what I've realized now, where we have seen is that there are many smaller cities that they want to create a policy on LGBTI, but they don't have many ideas where to start. So, of course, a prerequisite for the network is that they have an LGBTI policy and they don't have one. So, let's say that they would like to join, but they cannot because they don't have a policy.

So, the idea is to help, not only those who wants to join, but everyone not only Europe, but around the world who wants to create a policy at the local level to provide them with the tools. So, I can send to everyone the project that was sent to the European Union, if you want. However, I was or the idea is to speak for the first results, which I mentioned in the annual report. It seems six months from when the project was submitted, which it was at the end of September. So, that's why I didn't, let's see the whole project. However, in the email that I sent explaining, when I asked for your if you would like to be counted or not, I think I gave like an overall picture of what was the project about, but the standard right now is that we have to wait around February, March. I think it's going to be the state. I mean, the six months expire. And yes, so that's basically what is going to happen. I have to tell you, I guess I showed up with an email I contact the contact points because that's how they call from the European Union, they receive a draft of the project first, so they can give a feedback saying yes, it's good or probably you'd have to pay attention to this or that. And what I can tell you is like the feedback; it was very positive. I just have to be more accurate with some numbers, but I hope that we passed at least the second phase, but I will be informing you about it. And actually, in the website, you can see on the join activities that there are to be announced project. So, once we have that, we're going to put it there. And also, we're going to put the logo of European Union. So, I don't know if that's enough for an answer or weekend. #01:10:59#

Adriana Aguilera: Thank you. I think all of you can see me now, so that's good. I just wanted to clarify why Mexico City did not pay the fee last year for the amount was approved and contemplated in our budget, but we have a very restricted administrative terms and deadlines in order to transfer or use certain amounts. And though we asked for the invoice, unfortunately our administrative constraints orders us to have invoices in order to make any transactions. We did not receive it on time. It's not a blame. I, we know that on 2019 it was kind of hard to make the invoices, but that's the reason we couldn't pay. We had the amounts and it, I think it had to be before half of November, but since we did not have the invoice, our ministry of finance did not authorize us to make that transaction.

And I dare add the following four. I have been asked to inform that for next year, we will again be asking for the solidarity reduction, for we are planning our financial budget for next week, right next year, right now. And due to the ongoing Mexico city's administration implemented a deep austerity policy and added to that, we have been instructed to cut even more budget due to the pandemic. I know probably a lot more cities have been going through this. And I mean, I just wanted to say this in the annual meeting, even though I know that it has to be seen with the board and we have to make a letter directed to the board. And I just wanted to that. And yes, I mean, I just wanted to make clear that we have been active and we have been attentive to the mailing list. We have participated in the photo exhibitions and we will be doing so for next year. We have sent our one-pagers. We are very committed to the rainbow cities network and we would not like for our legal and administration constraints not to be the reason for us not to be in the rainbow cities network anymore. So, I just wanted to add that to my participation, but it will be sending the letter next year. #01:14:19#

So, that will be something that has needed to be discussed and approved by the next board with your city. But thank you for sharing that. So, Kristel I think you want to save something. So, if COVID allow us then all this, I mean, once the, let's say the budget is approved with them, then we can say, okay, this is what we, or this is how many cities can participate. So, I'm going to send an email to the whole network and ask who wants to participate. So, on that side event, we will have five, six, seven cities. So, if you want to participate, then you can come to Paris and present the best practices of Leuven to these other city networks that are going to be there also representative from other city networks. Usually, these networks are hosted within the UNESCO, like they are already part of the UNESCO. So, yes, there will be. I mean, I will be there too. And, but of course I will be speaking on behalf of the network as a whole, but talking specifically about the good practices, it's going to be city representatives.

So, six or seven people will come also to Paris, but again, once the money it's approved and of course, once we see that COVID allow us to do it because of course, if it's not the scope or the outreach of the conference, it's trying to be global. So, of course I'm sure if it's only European, I guess it will be good and positive or that only European cities come. But as I said, the goal of this organization is to bring city, I mean, youth organizations from everywhere in the world. So, it's going to be complicated for themselves if it's to be the lowest, then it's, that's what it's going to happen. All right, great. Let me see, thank you for those who have participated. Thank you for your comments on the chat. This, anyone has any other comments or questions that we'd like to be address? Right now, I mean, we are in good time right now. So, if you would like to, okay. Sao Paolo that we would like to use the floor again, go ahead. #01:17:27#

And we got, I think, four or five and in the end, it was three because two step back. So, it was Rotterdam, it was two, I think, in Germany. So, but it was quite about Europe. And in the end, we decided for somebody from the city he lives in Rotterdam, I think. But I knew didn't know him. So, till this point and then Danny, Manuel and Gheorghe is his name put a huge effort in creating the new website on filling the content and things like that. And in the end, you got it. I think one or two weeks ago, the result, and we are very happy about that. And the old one wasn't just quite fitting to the network and was, it was saying very less about the network in the end. And now it's done for us the new website thing, and we hope we can fill it with new cities and new information within the next years. Also, the programs we've talked about that recently, or Manuel talked about that, and then we are looking forward to the annual meeting, which is postponed to Bergen, but I think that will be a topic later. So, yes. And do you have any questions on the network on how the process was, or how it's looking or what you can do with it? A platform is just a technical remark. This it's the most accessible platform. And it's also a platform that guarantees us. We can use this site for many years. There's basically a little extra on the website. Also, Gheorghe already had quite some experience of working with the police of Rotterdam and he had quite a lot of references. It's not just, we randomly picked somebody. And I think I mean, at least with the board, we were very happy about the results that's it, on best practices and the website. #01:29:11#

Or do you just see that this light? Okay. So, recently I show on the on the annual report, I contacted all the cities that you were in contact before me. Some of them replied some of them, they haven't, some of them are already members but more recently I've been in contact. With the, if I mispronounced that, please forgive me. I've been in contact with the City of Ostende in Belgium and Rennes in France, Dusseldorf through-, Sören he put me in contact. I mean, people didn't come to me with those are in Haifa. Also, I've been in contact with Göttingen. And the good news is that last week, no, two weeks ago I was in a meeting with Madrid and they started the application now and they collecting the signatures. So, they will be joining us in January, 2021. I want, I mean, I didn't want to spoil the surprise, but now I can tell you a majority is joining in 2021, January. I have a call today, early with them today. So, they are just, they are checking all the details. So, they're collecting the signatures and they were not sure if they wanted to join. I mean, if they should join this year or next year, and since, you know, it takes time to collect the signatures and the approval and everything.

Yes, they agree that they will join or at least they would present the application in January. So, I can I explain the process so I can share with you their application and then, you know, the process, like get feedback and vote on it. But yes, they will be joining in January, 2021 also be Victoria, I think. Well, not thing you were in contact with them before I contact them too at the beginning. I mean, when I recently joined, however I've been not receiving a reply, but I participate in a forum three months ago, I think. And the three representatives was there, so was able to exchange emails with them and we have, a schedule meeting in two weeks to discuss also their application process. And finally, so yes, I mean, I also been in contact with Quebec. But there, I mean, sorry, Montreal and no Toronto, sorry, Toronto. And they are still waiting there. Let's say that's the more concrete ones. Like I know we have exchanged not only emails, some of them, I assume with

them. And as I said, Madrid will join in January or at least expect the application there. And of course, I'm still, the strategy is to I mean, that will be my pitch in. I'm trying to be careful when approaching citizen, the US or Australia, because I know that will, they might be interesting to join, but then, you know, this problem of hosting the event. So, it's always an issue. So, I'm being a little bit careful when it comes to that. So, I'm just trying to approach, I mean, so far European cities, so yes not only, but just like not pushing too much, so it grows organically. So, I guess I will give now the word to Juliane to reply the other question. And if I miss something, just remind me, because I was just writing the name of the cities. #01:36:35#

And that's the story behind the social media things. And that's a big part of going off, getting caught in contact with other organizations getting new cities. And yes, that's how we always discussing that because some part of the boards have of the board sometimes have big, great ideas. And yes, as you know rainbow cities, Latin American rainbow cities contacted us this year and we were supposed to or Amia was supposed to go there for their annual meeting because of COVID, it couldn't happen. So, basically what we're trying to create, it's a bridge and see, and find out where common grounds to work towards the same direction at the end. The important that'd be here is the advancement and defense of the LGBTIQ rights. So, yes. I hope that's okay with you for Florencio and then we'll proceed with Brussels and then Mannheim and then Vienna, so I receive your message, but I guess during intubation it's about that. So, I really just want to make a point. For me, it's more, very important to get out a lot of our network. I also have to justify why, we are a member there and there are not so many projects we do together, and I think it would be good to have more of that. That's it. Thank you. #01:45:24#

Manuel Rosas Vázquez: Thank you very much. So, I will go back now with European union project, if approve we are going to have a budget of 150,000 Euros that has to be expended in two years, that will not be operated big expenses. So, just so you have that in mind. So, basically, it's to have five events within two years besides the annual meeting. And of course, I know that some cities might say, Oh, I cannot ask my city to pay me to go to Arhus to an event, right, because they already paid me to go to the annual meeting. So, if the project is accepted and approved, that money will be to cover the expenses of you guys moving to these cities. And also, not to use, as I mentioned in my email regarding the project, at least the first two meetings, you will be able to come along with four more people.

So, your delegations will be, have five people. And then we, as the network, if we granted with the project, we'll be covering the expenses for your delegations. And in this let's say five meetings within the next two years, I think we'll be able to do have this project. And at the end, the outcome

of this great project will be this policy, right. So, I guess that will be also will contribute to their justification that you have to present to your cities. And I'm really looking forward and I'm waiting I'm positive to have those yes. To have that money so we can have that guidelines. So, yes, that's the idea, of course the money or, yes, the project is let's say we will allocate the resources within the EU members, but I don't know the input from other cities.

Like, I don't know, Geneva, like it's really close by we'll be taking in consideration and also from Sao Paolo or Mexico City, of course it will be an issue for us to, I don't know, allocate money to pay for the flight from Mexico City or to Sao Paolo, because at the end we have to show the money to the people in the European Union. So, yes, I mean the details, we can definitely work once we have the money. So, I will not like to spend a lot of time discussing this, not because it's not important rather, just because we might be discussing something that it might not happen. All right. So, we have a 50, 50% right now because we present everything. So, once we have it, we can figure it out, all the details, but nevertheless we are, or at least the project was conceived to include everyone on the network.

So, I will, Oh, and then just to answer your question we'll think yes, I contacted also, so Wolfgang asked, sorry for those, can ask about this situation in Istanbul. So, some of you already know that we have Sisli and other borough in Istanbul that were part of the network, but then I mean, they were gone for almost two years, so I contacted them at the beginning of the year. They replied and they said that I mean, they were reevaluating the membership because I mean the whole situation with the government. So, basically, we were in contact at the beginning of the year. They said we also offer that we would like to have them. We talk about also about them applying for the solidarity reduction so they can join the board agree that will be good because they've been going through a hardship.

So, but they didn't come back. Let's say our last contact was in April. So, but yes, that's the status basically. So, I, if I'm not mistaken in based on the bylaws or common grounds as they will call before when the city becomes inactive, not only not paying the fees, but also not answering the emails or anything, or attending to the annual meeting, they need to be cast out. So, that's what happened with them. However, as I said, the one, I mean, they show appreciation and they wanted to have them back. So, they have to reapply we myself with, along with the board, we provide all the information, all the facilities for them to join. But again, they, I mean, we haven't received any reply.

And after that, I mean we, or myself, I was focusing on yes, putting efforts into the website and on the application and yes, and doing the other job, but I guess I can write them an email asking or even a follow-up, but yes. So, is there any other questions we have literally six minutes left before we go to a break? If there is no other comments or questions, I would just like to ask you if you are okay with it. Then we have from Leuven as a suggestion social violence against LGBTIQ people, personal comment, I'm very skeptical about this as an, a photo exhibition, one wants it to be positive and to show good things. And I think this might be very difficult here and what I definitely don't want is to reproduce yes, violent speech of whatever. Next topic I think came from Berlin intersectionality diversity within the LGBTI new communities. It's a nice topic. I think then we have transgender children, not my personal favorite. As we already had an exhibition on transgender before then we had LGBTIQ or LGBTQ immigrants now the topic and intersex visibility, which I personally would skip, but I think it's too similar to number two. So, I think actually it would be the very same one and that would not choose the visibility again as we had it for lesbian visibility. So, I think it would be good to change the topic completely.
